

Dear Employee:

University of Wisconsin Medical Foundation Physicians Retirement Plan offers outstanding convenience and a variety of investment options through Fidelity. Take a look and see what a difference enrolling in the plan could make in achieving your goals.

Benefit from:

Tax-deferred savings opportunities. You pay no taxes on any earnings until you withdraw them from your account, enabling you to keep more of your money working for you now.

Investment options. You have the flexibility to select from investment options that range from more conservative to more aggressive, making it easy for you to develop a well-diversified investment portfolio. Your plan offers you the option of having experienced professionals manage your account for you.

Here are answers to questions you may have about the key features, benefits, and rules of your plan.

When am I eligible to enroll in the Plan?

There is no waiting period. You are immediately eligible to enroll in the Plan.

How do I enroll in the Plan?

UW Medical Foundation (through the Retirement Plan Committee) shall assign each eligible employee to one of six contribution categories. You must request one of the six contribution categories (0%, 5%, 10%, 15%, 20%, 25%) for the cycle period in which your start date falls through the end of that cycle period. If the Contribution-Category Assignment Request Form is not received by UWMF Human Resources within one week of your start date, you will be defaulted at 15% automatically for that cycle period.

How do I designate my beneficiary?

If you have not already selected your beneficiaries, or if you have experienced a lifechanging event such as a marriage, divorce, birth of a child, or a death in the family, it's time to consider your beneficiary designations. Simply fill out a beneficiary form and return it to your Human Resources office.

What are my investment options?

To help you meet your investment goals, the Plan offers you a range of options. You can select a mix of investment options that best suits your goals, time horizon, and risk tolerance. The various investment options available through the Plan include conservative, moderately conservative, and aggressive funds. A complete description of the Plan's investment options and their performance, as well as planning tools to help you choose an appropriate mix, are available online.

What if I don't make an investment election?

We encourage you to take an active role in the UWMF Physicians Retirement Plan and choose investment options that best suit your goals, time horizon, and risk tolerance. If you do not select specific investment options in the Plan, your contributions will be invested in the Vanguard Target Retirement Trust II with the target retirement date closest to the year you might retire, based on your current age and assuming a retirement age of 65, at the direction of UWMF.

If no date of birth or an invalid date of birth is on file at Fidelity your contributions may be invested in the Vanguard Target Retirement Income Trust II. More information about the Vanguard Target Retirement Trust II options can be found online.

Target Date Funds are an asset mix of stocks, bonds and other investments that automatically becomes more conservative as the fund approaches its target retirement date and beyond. Principal invested is not guaranteed.

When am I vested?

You are always 100% vested in your own contributions as well as any earnings on them.

Can I take a loan from my account?

Although your plan account is intended for the future, you may borrow from your account for any reason. Generally, the UWMF Physicians Retirement Plan allows you to borrow up to 50% of your vested account balance. The minimum loan amount is \$1,000, and a loan must not exceed \$50,000. You then pay the money back into your account, plus interest, by using Fidelity's Electronic Loan Repayment (ACH) service which deducts the payment from your bank or credit union account. Any outstanding loan balances over the previous 12 months may reduce the amount you have available to borrow. You may have two loans outstanding at any given time. The cost to initiate a loan is \$50.00, and there is a guarterly maintenance fee of \$6.25. The initiation and maintenance fees will be deducted directly from your individual plan account. If you fail to repay your loan (based on the original terms of the loan), it will be considered in "default" and treated as a distribution, making it subject to income tax and possibly to a 10% early withdrawal penalty. Defaulted loans may also impact your eligibility to request additional loans. Be sure you understand the Plan guidelines and impact of taking a loan before you initiate a loan from your plan account.

Can I make withdrawals?

Withdrawals from the Plan are generally permitted when you terminate your employment, retire, or become permanently disabled as defined by your Plan. The Age 55 Withdrawal transaction allows active participants, age 55 and older to make withdrawals from the Plan.

Can I move money from another retirement plan into my UWMF Physicians Retirement Plan account?

The plan allows for you to rollover account assets into your UWMF Physicians Retirement Plan, please be sure to complete the Transfer/Rollover form available by contacting Fidelity Investments. For any questions on completing the Transfer/Rollover form, please contact the Fidelity Retirement Benefits Line at 1-800-343-0860 Monday through Friday from 8:00 a.m. to midnight Eastern time.

Be sure to consider all your available options and the applicable fees and features of each before moving your retirement assets.

How do I set-up a confidential consultation with a Retirement Planner?

Dodge & Cox Balanced Fund

VRS Code: 893181

Fund Objective: The investment seeks regular income, conservation of principal, and an opportunity for long-term growth of principal and income.

Fund Strategy: The fund invests in a diversified portfolio of equity securities and debt securities. Under normal circumstances no less than 25% and no more than 75% of the fund's total assets will be invested in equity securities. It may invest up to 20% of its total assets in U.S. dollar-denominated equity or debt securities of non-U.S. issuers traded in the United States that are not in the S&P 500 Index.
