# 2 Program Overview

The Nursing Apprenticeship Program is a four-year program providing **a no-cost pathway** for current UW Health employees to pursue a degree in nursing while earning full-time pay and benefits. The program includes both formal classrooms learning at Madison College and the UW Health Apprenticeship Program Building as well as on the job training at UW Health and other approved clinical settings. Madison College is an accredited associate degree Nursing (ADN) program that prepares graduates to pass the National Council Licensure Examination (NCLEX-RN) to become a Registered Nurse. Apprentices will have access to a free Madison Metro Bus pass and must have their own plan for transportation to and from classes and clinical sites.

All applicants will be required to complete the ACCUPLACER at Madison College prior to April 30th. As noted on the Pulse, applicants

### 3 Eligibility Requirements & Program Expectations

### **Eligibility Requirements**

Any UW Health employee\* who meets the following requirements is encouraged to apply:

- Has earned a high school diploma or equivalent.
- Holds a Certified Nursing Assistant (CNA) credential in the state of Wisconsin.
- Must have passed their 6-month probationary period in current position.
- Not on a performance improvement plan, probation, or written discipline and none of the prior within the last 6 months.
- Have completed any commitments from previous positions or programs within UW Health.

### **Program Expectations**

If accepted, you will be required to:

- Sign a contract with the Department of Workforce Development (DWD) once the program starts.
- Sign an Employee Agreement committing to work for UW Health as a Registered Nurse for at least 24 months after program completion or reimburse the full (\$10,000.00) or prorated cost of the program.
- Maintain a 1.0 FTE (40 work hours/week). The number of hours on the unit vs. the number of hours in the classroom will vary from semester to semester depending on courseload. Apprentices are assigned to work 40 hrs./week on the unit during academic breaks).
- Maintain all UWH and Madison College eligibility requirements to participate for the duration of the program (4-Years).
- Attend all classroom and clinical sessions. Be active and engaged in class. UWH policies apply to work hours completed in the academic setting.
- Maintain a passing grade in all courses while enrolled at Madison College that meet program requirements for the nursing program.
- Complete all homework assignments (approx. 9-12 hours/week or more per class) outside of the classroom on your own time (unpaid).
- Successfully pass the WI NCLEX Board upon completion of the 4-year program.
- Maintain American Heart Association (AHA) Basic Life Support (BLS) Certification for Healthcare providers (CPR) and any other UW Health or Madison College competencies throughout the program.

\*Temporary employees, employees in training, and student employees are not eligible to participate in the program.

(Youth Apprenticeship Participants are exempt from student employment status).
